PHOTOBOOTH SERVICES ORDERED:

Basic Rental \$349

This includes Two (2) hours of Photo booth rental, Customized Printout Design, Unlimited number of Shots and Prints per, (Unlimited prints means only one photo print-out per session), Free use of FAB accessories like hats, mask, etc. , Onsite Printing on 4x6 inch Photo Paper, White/ Black backdrop, Appropriately dressed attendant, 1 archive of prints, Free delivery, set up and breakdown of photo booth within 10 miles of Chino Hills

Basic Package Plus \$449

Basic Package with three (3) hours Photobooth rental. Save \$50 on the extra hour!

FAB Package \$649

This is the Basic Package with four (4) hours of Photobooth rental and upgraded 5x7 photo paper. Save \$100 on this package!

Extra hour rental \$150

Ordered in advance. May be requested on the day of event, pending supplies available.

Traveling fee (11+ miles away from Chino Hills) \$0.75/ mile

This charge is for after the 1st free 10 miles.

5x7 Prints Upgrade \$50 every 2 hours

This upgrade will give your guests a 5x7 inch size print of their photobooth session.

Double Prints (4x6 size) \$40/ 2 hours

You will get two (2) 4x6 printouts per session. Instant copy for you and your guests!

46" LCD Monitor for Slideshow images of FAB Photobooth session *** \$200

Fascinate your guests by featuring their FAB Photobooth session on a big screen! Note that what we would recommend would depend on your event lighting. Our 46"LCD monitor is best for events that will be using bright lighting conditions. If your event has a darker setting, our LED Projector would be best to feature your images and projected bigger than 46" on the wall or ceiling.

Rush Fee \$50.00

For any events booked/ contract is signed 7 days or less from the event date, we will charge a fee of \$50 on top of your rental. This will include events booked earlier but other requirements needed submitted 7 days or less from the event date. So avoid this surcharge and book your event early!

PHOTO BOOTH REQUIREMENTS:

- 10 x 10 Feet space for photo booth set-up (including booth, backdrop and space for the guests to gather).
- Please allow 1 hour set-up time prior to start of the event. This is not included in your rental period.
- Parking space and/or fee for delivery vehicle
- Meal for 2 people
- 1 3-prong electrical outlet

PAYMENT TERMS:

1. A reservation fee of 50%, deductible from the total amount along with the signed contract is required to confirm date reservation. \$100 of the deposit is strictly NON-REFUNDABLE. The rest is refundable should you choose to cancel the event 7 days before the event.
2. Remaining balance must be paid on or before the event

FAB PHOTOBOOTH & CLIENT AGREEMENT:

1. If FAB Photobooth cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then FAB Photobooth will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of FAB Photobooth. Client(s) agree that an entire event cannot be replicated, reenacted or repeated for the purpose of a re shoot and limits FAB Photobooth's liability to the amount paid under this contract.
2. On signing of this agreement by both parties hereto, FAB Photobooth will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all reservation fees/ deposits are non-refundable even if the date is changed or if the event becomes cancelled for any reason.
3. The total service fee is \$_____ includes ____ hours of FAB Photobooth service and all included additional optional services, if any. A deposit of \$_____ is due at the signing of this agreement, with a further payment of all necessary expenses (unless otherwise specified). No service will take place and no rights are granted until timely payment is made in full.
4. Damage/ Missing Props/ FAB accessories: We will charge a minimum of \$5 and a maximum of \$30 for any props or FAB accessories damaged or missing at your event.
5. Legal Release & Notice of Copyright: All digital photos are copyrighted to and remain the property of FAB Photobooth, which retains the exclusive license and reproduction rights for use in promotional and advertising venues. It is ILLEGAL to copy or reproduce (digitally, photographically, with the assistance of a third party lab, or by any other unspecified means) these photographs elsewhere without the Photographer's express written permission. Violators of this Federal Law will be subject to its civil and criminal penalties, and FAB Photobooth will prosecute to the fullest extent of the law. By utilizing the photobooth services of FAB Photobooth, the client releases all digital images to be used in marketing collateral materials, magazine ads, and any other future promotion or publication purposes not specified here. Clients further grant the right and permission to use and/or publish said digital images, either in original or computer-altered format, in conjunction with client's own or a fictitious name, in any reproduction through any media for any purpose, forever. Clients release and discharge FAB Photobooth, and/or its representatives and affiliates, in whole or in part, from and against any liability and harm as a result of any use of said digital photos, or any alteration which may occur intentionally or otherwise, in the reproduction of the finished product, its publication or distribution. This copyright excludes anyone except FAB Photobooth from making identical or substantially similar copies of the work, from creating adaptations or derivatives of the original work, from re-selling the work in any way, and from displaying the work publicly or as a for-profit marketing/advertising technique.
